Dear Lakeview Family,

A couple of things happened this past week that have spurred me to address the issue of gambling, or euphemistically called "gaming." First, a longtime friend of Heather's and mine told Heather, matter-of-factly, that her son gambles for a living. There seems to be no concern on the part of this mother; in fact, she says because her son is good with numbers and math, he is good at gambling and does well for himself. Keep in mind, Heather's friend is a professing Christian and raised in the church.

Second, you may well know, the Alabama House of Representatives last Thursday, February 15th, passed a legislative package that, if approved by the Senate and state voters, could create a state-regulated gambling industry for the first time in history. The legislation, if approved, would create a state lottery, and authorize seven casinos as well as sports wagering. One of the arguments for this push is that Alabamians are traveling to other states to gamble and helping those states with their education and infrastructure in the process. "We should bring this money home," one state representative argues.

So the question I would like to address is how Christians are to think about gambling. Let's define gambling first. Edward Rogers, in an article in The Westminster Dictionary of Christian Ethics, defines gambling as the "attempt to acquire money or money value, by appealing to an artificially created chance, in which the gains of the winners are made at the expense of the losers and the gain is secured without rendering an equivalent service or value." In line with that definition, Daniel Heimbach defines gambling as "transferring ownership of something of value based on chance, using a contrived risk to settle winners who gain at the expense of losers, all without anyone doing anything to earn or forfeit the value exchanged and without producing anything constructive."

Based on these definitions, gambling favors one, or a few, at the expense of others. Additionally, gambling is for the purpose of getting something for nothing - others lose.

J. Alan Branch, in his book on ethics, points out, gambling in the U.S. was once restricted to Las Vegas but now has permeated every corner of America. What makes this ethical issue a bit challenging to address is there are no specific Bible verses that directly prohibit gambling. The only time gambling is specifically referenced in the Bible is when the soldiers cast lots for Jesus' garments at the foot of the cross (Matthew 27:5; Mark 15:24; Luke 23:34; John 19:24).

With that said, while there is no verse that says, "Do not gamble," I would argue that the implication is strongly there. Proverbs 10:2 "Treasures gained by wickedness do not profit, but righteousness delivers from death." Isaiah 65:11-12 condemns worshiping gods of chance. Indeed, the LORD (Isaiah 65:1) warns of certain judgment for worshiping the "god of Fate" and "Destiny" (65:11, NLT). Does the Lord not condemn here the transferring of anything of value based on nothing but chance?

Then there is the issue of stewardship. We are called to be good stewards of our money (Luke 16:10-12). Indeed, Jesus says, "And if you have not been faithful in that which is another's, who will give you that which is your own?" (Luke 16:12). It is the same as someone trusting you with something he owns and you squandering it instead of using it wisely and returning it with interest (Matthew 25:27).

Then there is the path of devastation gambling leaves behind. Several years ago, I was in Las Vegas with Heather because she was performing at a concert. I had to leave early so I took a cab to the airport. I mentioned to the cab driver that I figured he had some interesting stories as a cab driver in Las Vegas. He said, "Yes, and sad stories. There is not a week that goes by when I do not drive a man to the airport who has to go tell his wife he just lost everything." Of course, that speaks to the addictive nature of gambling.

In fact, according to the National Council on Problem Gambling, gambling addiction costs society at least \$6 billion annually. The California Council on Problem Gambling reports that according to a 2006 California survey, problem gamblers are three to three and a half times more likely to be arrested or spend time in jail, and are two to seven times more likely to binge drink, and take illegal drugs than others.

Speaking of increase in crime, one study done by researchers at Baylor, UGA, and the University of Illinois, found that 8% of crimes in counties that had casinos were attributable to the presence of the casinos. A University of Maryland study on Indian casinos found that auto theft, larceny, and bankruptcy increased by 10% in communities that allowed gambling.

And then there is the reality that state—sponsored gambling is a tax on the poor. A 2013 study from the University at Buffalo Research Institute on Addictions found that the poorer a neighborhood is, the greater the risk is for gambling addiction. According to the National Gambling Impact Commission, in 1999, people with annual incomes of less than \$10,000 spent three times as much on gambling as those with incomes of more than \$50,000. According to the National Center for Policy Analysis, which cites research by the National Gambling Impact Study Commission at Duke, households earning \$10,000 spend twice as much on gambling as households earning \$90,000. This translates to the lowest-earning households spending roughly 10.8% of income on gambling compared to .7% of income for the highest earners. That makes sense of a study in the American Indian Law Journal, which looked at two dozen tribes in the Pacific Northwest between 2000 and 2010. During that time, casinos owned by those tribes doubled their total annual take in real terms, to \$2.7 billion. Yet the tribes' average poverty rate went from 25% to 29%. Is this not what the wisdom writer warns against when he frowns upon "Whoever oppresses the poor to increase his own wealth" (Proverbs 22:16)? Or the Apostle Paul when he exhorts "Let no one seek his own good, but the good of his neighbor" (1 Corinthians 10:24).

For all these reasons, and more, let us pray that this legislative package is not approved by the Senate. Indeed, "wealth gained hastily will dwindle" (Proverbs 13:11).
